Topic	Discussion	Action/Decision
Updates on Ordinance Changes	There are a few things we still need to do to finalize proposed changes and the procedures that will help with implementation. The following areas got the most input at the Public Workshop.	
Pet Limits	Brigid and Jennifer gave a report on the meeting with the wildlife groups, reminding us that the goal all along has been to reduce the feral cat population through trap/neuter/release. To address concerns raised about removing the cat limit, the group reviewed an approached used in San Antonio that allows excess animals by permit. This approach would not require the limit on cats to be changed in the ordinance but would provide a solution by allowing an avenue for people who are willing and able to foster animals to apply to have excess animals. Applications are reviewed on a case-by-case basis.  The group also agreed to not pursue the requirement for licensing cats. Rather the group agreed on a voluntary and educational approach, encouraging cat owners to register their cats and ideally keep them indoors or in enclosed patios outdoors.	Brigid to send Ellen current application forms for pet fancier and kennels so they can be updated by program staff and be consistent with Excess Pet Permit form.  Public Health Program Support and Animal Services staff will research the San Antonio Excess Animal permit process and try to identify whether another CA jurisdiction has implemented a similar approach.
Barking Dogs	County Counsel suggested that we consider the Orange County approach to dealing with barking dogs (which is the best practice we researched previously). We will need to do further research to understand the costs involved in implementing this approach.  As a follow up to the Public Workshop, Brigid will work with County Counsel to develop a definition for nuisance barking and any other changes needed to the ordinance.  Brigid noted that there is most often resolution when neighbors talk to one another, and the criminal process is lengthy and ineffective. Already Animal Services is improving its procedures with a letter to the owner and a letter to the complainant.	Brigid to define nuisance barking.  Brigid to update proposed Barking Dog Procedure.
Standard of Care	County Counsel has some suggestions and revisions for us on this, mostly on clarity of definitions.	Brigid will send next version of Standards of Care with the actual draft document to the workgroup when ready.
